provision, training and capacity building of community leaders, Justice Law and Order Sector actors to impart knowledge, skills, and influence change of attitude in order to promote human rights, the rule of law, good governance, and administration of justice. She has worked with Amnesty International Netherlands, the World Bank, UNHCR, UNFPA, and UNDP among others. She is a trainer with rich experience in curriculum development and production of training manuals on gender-based violence, and an international legal expert who has significantly contributed to enactment of legislation and jurisprudence both at the national level in the Republic of Uganda; and at the regional in the East African Community and the International Conference on the Great Lakes Region (ICGLR) on Women Peace and Security issues. Noel also worked with the GOU Irish Aid Project to address GBV in Busoga region that saw reduction in prevalence of GBV in the region.
